A. Beneficiary's Personal Documents	
Resume or CV	
Passport (all biodata pages, all stamped pages)	
Education Documents (diplomas and transcripts)	
All previous USCIS Approval Notices (H-1B, L-1, H-4 etc)	
All I-20 and EADs for F-1	
Entry I-94 (retrieve electronic copy from CBP website)	
B. Evidence of advanced degree in the field of expertise.	
Official academic record (Degree certificate and transcript) showing you have a U.S. advanced degree or a foreign equivalent degree; OR	
Official academic record (Degree certificate and transcript) showing that you	
have a U.S. baccalaureate degree or a foreign equivalent degree and letters	
from current or former employers showing that you have at least 5 years of	
progressive post-baccalaureate work experience in the specialty.	
C. Evidence of Exceptional Ability (alternative to advanced degree)	
Evidence that you have at least 3 of the following:	
Official academic record showing that you have a degree, diploma, certificate, or similar award from a college, university, school, or other institution of learning relating to your area of exceptional ability	
Letters documenting at least 10 years of full-time experience in your occupation	
3. A license to practice your profession or certification for your profession or occupation	
4. Evidence that you have commanded a salary or other remuneration for services that demonstrates your exceptional ability	
5. Membership in a professional association(s) that require their members to demonstrate outstanding achievement.	
6. Recognition for your achievements and significant contributions to your industry or field by your peers, government entities, professional or business organizations	

7. Oth	er comparable evidence of eligibility is also acceptable.	
D. Re	commendation Letters by field experts.	
They s	hould include the following:  Writer's qualifications to issue his/her opinion.	
•	Alien's background and achievements as well as commentaries on how the alien's achievements are original contributions of major significance.	
•	Commentaries on the significance of the alien's publications, awards, and memberships in professional associations, if any.  Alien possesses unique knowledge, abilities, or experience that sets him/her apart from his/her professional peers.	
•	Alien will utilize these unique talents in an activity significantly benefiting the U.S. in the future
